

We had a very successful CTCHIP event last year at GVAA on Sept 15, 2007. This year a bike safety/rodeo will be offered from 10-11 AM by Bicycles East, a local bike shop in town. Volunteers arrive by 9:30 AM. The parents or guardians of the children will be provided with five means of identification: a DVD video interview, a DVD still photo, fingerprints, a Toothprint bite impression, and a DNA swab as well as a height and weight check. As always, our hope is that there will never be a need to use this identification.


