This happens to be my 45<sup>th</sup> year. I was raised in 1974 and then was elected Marshal in 1975. Back then our lodge was one of the biggest in the state, with

approximately 1,000 - 1,400 members. To be elected Marshal was no easy task, since it was highly contested. Fortunately for me, I had the backing of our Fellowcraft Club at the time, since my father was a trustee of the club. Also, if elected, the tradition required you to take every brother present out for refreshment (Thanks, Dad).

In those years, Grand Lodge rules and regulations forbid the Lodge from doing any social activities. The Lodge Fellowcraft Club, with the permission of the Worshipful Master, provided most social activities.

The dress code for all Stated Communications was Tuxedo for Officers; members and guests a suit or jacket and tie. Officers were to know their required ritual and floorwork. If an officer did not learn what was required, he would probably not be re-appointed or elected at the next Lodge election.

This was just a little of how our Lodge was back then. It might sound strict, but we also had our moments. I hope to continue the memories in future *Trestleboards*.


