NOV – DEC 2024 From the Secretary's Desk

I am addressing only about ¼ of the population of this lodge today. To the ¾ that it doesn't apply to, I thank you, and encourage reading it anyway...maybe you can suggest some way to help the lodge with this persistent problem. I am out of ideas myself.

It's a subject that I've often thought about but have never put down here before because it isn't "universal" enough for my taste and is frankly

negative. Today, though I feel it needs to be aired out. My topic is simply a question:

WHY HAVEN'T YOU PAID YOUR DUES?

I'm in my office this morning doing two things that come up every year at this time: putting together the 3rd notice for dues to those who haven't yet paid and also working up the next year's budget. This is by far the longest list I've ever had for the 3rd notice mailing, so I naturally ask myself the question. Does the amount of the dues represent financial hardship? Did the previous 2 notices get lost/forgotten? Are you thinking of leaving the fraternity?

We have a program at this lodge whereby the Worshipful Master and Wardens get the list of potential NPD (Non-Payment of Dues) members and call them to ask these questions. It's a chore, because it puts the caller in the position of having to beg for something that is owed the lodge. Paying your dues is explicitly part of your obligations as a Mason. Dues are the single largest source of income for the lodge, and also the second largest liability, after the rent we pay to the building. So not paying dues hurts the lodge 2 ways: by lost income and avoidable expense. "But wait", you might say, "what avoidable expense?"

It's like this: of the \$200 amount of your dues, \$65 of it has already been paid to the Grand Lodge. There's also a certain amount of money spent on each of you already in the form of postage and supplies in the previous 2 dues requests. And now, for the 3rd mailing, the lodge is going to spend an additional, un-budgeted amount of \$15 per person to send a registered letter out to you to ensure that you've gotten every opportunity to stay current in your membership. So you who haven't yet paid have COST the lodge \$80 each to date.

As far as next year's budget goes, my problem becomes this; do I make a budget that has 120 dues paying members, or one with 90? Brethren, we are not in any way a wealthy lodge. We utterly depend on the support of the membership for everything we do, not just financially but physically.

Maybe you haven't paid because you think the dues aren't really due until the end of the year? Let me dispel that notion: Dues are due on January 1^{st} . On January 2^{nd} , you are officially delinquent. If you have been in the habit of paying in the fall, please think about amending that habit to pay earlier in the year. Perhaps the dues are too much for your present situation. PLEASE, reach out to me or the Worshipful Master (or another trusted Brother) – we WILL work with you and figure out a way, I Promise.

Are you thinking of leaving entirely? First, please give me a call and I'll try to talk you out of it (gently) but I'll explain the process and consequences. I'll say that this is an exciting time to be a

member of this lodge: we are seeing a resurgence in interest from younger men to be part of our fraternity; they need the guidance and experience that you have to offer, if you are willing and able to continue on this path. We'd love to keep you!

So – if you get a registered letter in the next few days, please act on it. Send the check, or send a note, or make a call. As much as I dislike sending them, I hate acting on the silence even more. Before closing, I'd like to thank all the Brothers who reached out to me with support over the past few months while working through my Mother's sickness and death and beg your indulgence and patience while I work through the disposition of her estate. It means the world to me.

Hope to see you in Lodge this fall!
